7. Associate Editor, Journal of IACM One

Nomination form completed in all respect should reach the IACM office not later than 31st March, 2026. The nomination form must be accompanied by a Demand Draft of Rs.1500/- (Rupees One Thousand Five Hundred only) drawn in favour of INDIAN ASSOCIATION OF CLINICAL MEDICINE payable at AGRA. More than two nomination and nomination form not accompanied by a demand draft shall be deemed invalid.

Rules relating to qualification for election as by constitution are as follows:

Rule 3.3.3 (i) For the post of President-Elect and Vice Presidents a candidate shall have held an elected position in the Governing Body at least for one year.

Rule 3.3.3 (ii) For all other positions, continuous membership of the Association for at least one year.

Rule 3.3.4 No member shall be eligible to seek election consecutively or otherwise for more than 1 tenure as President-Elect, more than 2 tenures as Vice-President.

- Rule 3.3.5 No member shall hold the post of Honorary General Secretary, Honorary Treasurer or elected Member Governing Body for more than threetenures in any particular position. The total duration of office in the Governing Body in all these posts put together shall not exceed 6 tenures.
- Rule 3.3.6 The President/President-Elect shall not seek election for any position in the Governing Body in future.
- Rule 3.3.7 Any person holding any office bearer post shall not contest any other post whose tenure starts during the pendency of his office. A member shall not contest simultaneously for more than one office bearers post.
- Rule 10.2 The Honorary Editor' post shall be filled by inviting nominations from amongst the members of the Academy. The Credential Committee will review these nominations and recommend 3 names to the Governing Body in order of merit for consideration and to nominate one person out of these as Honorary Editor. The Editor so nominated shall hold the position for a period of 3 years but shall be eligible for re-nomination so as to have a total tenure of not more than 6 years.
- Note: Same procedure as of Rule 10.2 will be adopted for nomination of Honorary Associate Editor' post.

Members are requested to note the following:

1. Ballot papers will be posted to all Founder Fellows/Fellows/Life Members by 30th April, 2026 and the last date to receive back the ballot papers at IACM office is 15th June, 2026. If any member fails to receive the ballot paper within a reasonable time, kindly intimate the IACM office and a duplicate ballot paper will be supplied immediately on written request. If such members receive the original ballot paper also the same should be returned at once to IACM office.
2. Date of counting the ballots will be intimated to the contestants in due course.
3. The result of election will be announced in the next Governing Body meeting.

IMPORTANT

The members are duly informed that as per constitution of the Association a short Bio-data not exceeding 200 words shall accompany the nomination form which shall be printed and circulated along with the ballot paper. Bio-data should be restricted to 200 words, if it exceeds the first 200 words will be printed for circulation. Canvassing in any form other than this should not be made by the contestants for the election.
